5 Application of product 1/2 inch from scalp to porous ends *BACK RIGHT PANEL

Product applied too close to scalp

5 Sub-sections are 1/8 inch wide

Product applied too far from scalp

10 Section must be completed

Product not applied down to the porous ends 1/2 inch to 1 inch of the ends of long hair.

**NOTE: If hair is 4 inches or shorter product must be applied on the entire strand. If hair is longer than 4 inches, product must be applied down the strand approximately 1/2 inch to 1 inch of the ends.

Short hair, product not applied to the ends

Sub-sections too wide

Not on BACK RIGHT PANEL

Section incomplete

Product not visible on both sides of the strand



SET AND COMB OUT




- 1. SET MUST INCLUDE ROLLERS AND PIN CURLS**

COMB OUT

- 1. ROLLERS MARKS MUST NOT BE VISIBLE**

ROLLER PLACEMENT

DOTTED LINES INDICATES THE ANGLE THE HAIR IS HELD


ROLLER # 1 (ON BASE)

ROLLER # 2 (1/2 OFF BASE)

ROLLER # 3 (COMPLETELY OFF BASE)


Roller # 4 (Roller in a shaping)

1. Comb hair into a shaping.
2. Place roller at the beginning of the hair and roll into the shaping.
3. Clip the roller at the open end of the shaping.




Only yellow rollers

1. Rollers must be no longer than 2 ½ inches in length & 1 inch in diameter.



PIN CURL CONSTRUCTION


1. Under the roller in a shaping create a section about the size of the roller as shown.
2. Sub-divide the section into 3 equal sections for the pin curls.
3. Create three pin curls as shown on base, half off base & off base
4. Comb the remainder of the hair into shapings.
5. At the open end of one of the shapings construct a pin curl. (This is your pin curl in a shaping as required.)






DIAGONAL SKIP WAVE

1. Create a wave pattern in front of the ear as shown.
2. In the second shaping, create Counter clock wise pin curls.
3. At the top of the ear create another wave pattern as shown.
4. In the second shaping, create Counter clock wise pin curls.



VERTICAL BRUSH WAVE


1. In front of the ear create a row of COUNTER CLOCK WISE PINCURLS
2. On top of the ear create a row of CLOCK WISE PIN CURLS
3. Behind the ear create a row of COUNTER CLOCK WISE PINCURLS



1/4 sub-sections

Apply color on scalp

to 1/2 inch of hair strand.




HAIR COLOR RETOUCH

You will need to retouch the new growth as the hair grows in order to keep it looking attractive and to avoid a two-toned effect. Hair grows approximately 1/2 inch per month.

1. 1/4 inch sub-sections
2. Beginning at the scalp, apply the color on the scalp and up to 1/2 inch of the hair strand.
3. Product must not exceed the 1/2 inch re-growth because hair grows approximately 1/2 inch per month.

NOTE: MANNEQUIN HEADS THAT HAVE BEEN PURCHASED PRE-SECTIONED INDICATING SECTION BY VARIOUS COLORS UNDER/OR NOTCHES ARE NOT ALLOWED.

NOT: MANNEQUIN HEADS THAT HAVE BEEN FLAT IRONED ARE NOT ALLOWED.




FRONT LEFT PANEL

SIX WHITE RODS MINIMUM

PERMANENT WAVE

- 1. Wrapping procedure/rubber bands/long white rods.***
- 2. Use of end papers in relation to strand of hair. Preferred method (double end papers)***
- 3. Position of rod on scalp in relation to size of strand and size of rod. All rods are to be rolled half off base.***
- 4. Sectioning/neatness and size according to white rods and a minimum of six rods. (Front left panel.)***


NOTE: Half off base placement refers to wrapping the hair at a 90 degree angle or straight out from the center of the section. Half off base placement minimizes stress and tension on the hair.




FOIL HI-LITE

- 1. Foil section must be at the front right panel,**
- 2. Placement of foil/Close to scalp**
- 3. Strands must be weaved and completely saturated with product.**
- 4. Section must be completed.**


VIRGIN BLEACH



RELAXER RETOUCH



90 DEGREE UNIFORM LAYERED HAIRCUT



1. THE HAIR MUST BE THE SAME LENGTH THROUGHOUT THE ENTIRE HAIRCUT.
2. STUDENTS MUST CUT NO LESS THAN 1 INCH.
3. THE HAIRCUT MUST NOT BE SHORTER THAN 3 INCHES IN LENGTH.
